2. Authorize the use of pre-qualified vendors (Attachment A), as amended, by all Authorized Entities as defined in Board Policy H-7.



BACKGROUND:

Summary

On December 12, 2023 (M.O. 3.19), the Board of Supervisors (Board) approved a list of pre-qualified vendors for various professional real estate services, in accordance with Board Policy H-7: Selection of Architectural, Engineering and Real Estate Related Services. There is now a need to augment and expand the previously approved Attachment A - Pre-Qualified Vendors for Professional Real Estate Services, and to expand the current list of vendors and provide for greater options and services when selecting vendors.

In accordance with Board Policy H-7 and Government Code 4526, Facilities Management – Real Estate (FM-RE) recently advertised the Request for Qualifications (RFQ), soliciting additional firms with relevant professional real estate service experience. The RFQ included the provision that the previously approved Attachment A - Pre-Qualified Vendors for Professional Real Estate Services would be amended, but still include all vendors that had already been selected for the list as a pre-qualified vendor. After reviewing the submitted qualifications, the selection committee made recommendations to add the pre-qualified consultants listed in Table A below. Services will be retained on an as-needed basis, through the issuance of a contract or purchase order in accordance with applicable Board policies.
