

BACKGROUND:

Summary

The purpose of the FY24 State Homeland Security Grant Program (SHSP) is to support state and local efforts to prevent terrorism and other catastrophic events and prepare the nation for the threats and hazards that pose the most significant risk to the security of the United States.

On behalf of the County, Emergency Management Department (EMD), as the lead County agency, applied to Cal OES for the FY24 SHSP Grant. On October 28, 2024, Cal OES awarded EMD federal pass-through funding in the amount of \$2,130,587, and the Board accepted these funds January 28, 2025 (Minute Order 3.6) on behalf of the participating cities and agencies in the Riverside Operational Area to enhance the County's abilities to prevent, deter, respond to, and recover the threats and incidents of terrorism and other catastrophic events. Since 2007, the Riverside County Sheriff's Office (RSO) has received a share of SHSP funding for projects meeting the State of California Homeland Security strategic objectives that demonstrate a nexus to terrorism.

The Sheriff's Office recent SHSP awards include:

- SHSP FY23: \$322,516/Board Approved on July 30, 2024 (Minute Order 3.74)
- SHSP FY22: \$223,850/Board Approved on June 27, 2023 (Minute Order 3.85)
- SHSP FY21: \$232,511/Board Approved on May 24, 2022 (Minute Order 3.24)

- SHSP FY20: \$480,799/Board Approved on September 21, 2021 (Minute Order 3.25)
- SHSP FY19: \$658,887/Board Approved on November 5, 2019 (Minute Order 3.22)
- SHSP FY18: \$82,368/Board Approved on December 17, 2019 (Minute Order 3.38)

RSO has been awarded funding under the FY24 SHSP to enhance regional security and emergency response capabilities. Proposed initiatives include:

- \$300,000 for the Safety Tribal Regional Analysis Center (STRAC) which is a multi-agency partnership between federal, state, local, local tribes, and private sector partners in the Inland Empire. The STRAC center will collect, analyze, and disseminate actionable information to defend against major threats in the inland region while ensuring the highest regard for the protection of civil rights and civil liberties. This amount will fund salaries and benefits for two Crime and Intelligence Analyst II positions for the STRAC center.
- \$100,000 to purchase start up equipment, software and technology related databases and resources for the STRAC center.
- \$183,585 for the Sheriff's Emergency Response Team (SERT) to purchase a Counter Unmanned Aircraft System (C-UAS) to detect, track, and mitigate drone-related threats, enhancing the team's capacity to safeguard critical infrastructure and public events.
- \$67,000 for the Sheriff's Hazardous Device Team (HDT) for the procurement of Personal Protective Equipment (PPE) and a Self-Contained Underwater Breathing Apparatus (SCUBA). This equipment allows divers to operate independently underwater aiding in the recovery of drowning victims, missing persons, and evidence to aid in criminal investigations.

These initiatives directly support SHSP's mission to strengthen the capabilities of local agencies in preventing, protecting against, mitigating, responding to, and recovering from acts of terrorism and other major incidents.

Impact on Residents and Businesses

These funds have no adverse effect on citizens or businesses. Local law enforcement officers will be fully trained and equipped to respond to a terrorist attack.

Additional Fiscal Information

The Sheriff's Office received notification of project approval in FY24/25 and is requesting a budget adjustment now as it could not anticipate the additional revenue or expenditures in the FY25/26 budget request. The grant is federally funded through CalOES and is 100% reimbursable. EMD will reimburse the Sheriff's Office via an intra-fund transfer for allowable expenses upon completion of the projects.

WHEREAS, the Board of Supervisors of the County of Riverside, State of California, in regular session on January 28, 2025, Minute Order 3.6, accepted the Fiscal Year 2024 State Homeland Security Program ("FY24 SHSP") grant funding from the California Governor's Office of Emergency Services ("Cal OES") for a total aggregate award amount of \$2,130,587 for the performance period of April 23, 2025 through May 31, 2026, awarded to the Riverside County Operational Area with the Emergency Management Department ("EMD") as the lead agency;

As the duly authorized representative of the Applicant, I hereby certify that the Applicant has the legal authority to apply for federal assistance and the institutional, managerial, and financial capability (including funds sufficient to pay any non-federal share of project cost) to ensure proper planning, management, and completion of the project described in this application, within prescribed timelines.

I further acknowledge that the Applicant is responsible for reviewing and adhering to all requirements within the:

2. **Period of Performance**

The Applicant will initiate work after approval of the award and complete all work within the period of performance specified in the grant.

3. **Lobbying and Political Activities**

As required by Section 1352, Title 31 of the United States Code (U.S.C.), for persons entering into a contract, grant, loan, or cooperative agreement from an agency or requests or receives from an agency a commitment providing for the United States to insure or guarantee a loan, the Applicant certifies that:

- (a) No federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of an agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any federal grant, the making of any federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any federal contract, grant, loan, or cooperative agreement.
- (b) If any funds other than federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying", in accordance with its instructions.
- (c) The undersigned shall require that the language of this certification be included in the award documents for all subawards at all tiers (including subcontracts, subgrants, and contracts under grants, loans, and cooperative agreements) and that all subrecipients shall certify and disclose accordingly.

The Applicant will also comply with provisions of the Hatch Act (5 U.S.C. §§ 1501-1508 and §§ 7324-7328) which limit the political activities of employees whose principal employment activities are funded in whole or in part with federal funds.

Finally, the Applicant agrees that federal funds will not be used, directly or indirectly, to support the enactment, repeal, modification or adoption of any law, regulation or policy without the express written approval from the awarding agency.

4. Debarment and Suspension

As required by Executive Orders 12549 and 12689, and 2 C.F.R. § 200.213 and codified in 2 C.F.R. Part 180, Debarment and Suspension, the Applicant will provide protection against waste, fraud, and abuse by debarring or suspending those persons deemed irresponsible in their dealings with the federal government. The Applicant certifies that it and its principals, recipients, or subrecipients:

- (a) Are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from covered transactions by any federal department or agency;

5. Non-Discrimination and Equal Employment Opportunity

The Applicant will comply with all federal statutes relating to non-discrimination. These include, but are not limited to, the following:

- (a) Title VI of the Civil Rights Act of 1964 (Public Law (P.L.) 88-352 and 42 U.S.C. § 2000d et. seq.) which prohibits discrimination on the basis of race, color, or national origin and requires that recipients of federal financial assistance take reasonable steps to provide meaningful access to persons with limited English proficiency (LEP) to their programs and services;
- (b) Title IX of the Education Amendments of 1972, (20 U.S.C. §§ 1681-1683, and 1685-1686), which prohibits discrimination on the basis of sex in any federally funded educational program or activity;
- (c) Section 504 of the Rehabilitation Act of 1973, (29 U.S.C. § 794), which prohibits discrimination against those with disabilities or access and functional needs;
- (d) Americans with Disabilities Act (ADA) of 1990, which prohibits discrimination on the basis of disability and requires buildings and structures be accessible to those with disabilities and access and functional needs (42 U.S.C. §§ 12101-12213);
- (e) Age Discrimination Act of 1975, (42 U.S.C. §§ 6101-6107), which prohibits discrimination on the basis of age;
- (f) Public Health Service Act of 1912 (42 U.S.C. §§ 290 dd—2), relating to confidentiality of patient records regarding substance abuse treatment;
- (g) Title VIII of the Civil Rights Act of 1968 (42 U.S.C. § 3601 et seq.), relating to nondiscrimination in the sale, rental or financing of housing as implemented by the Department of Housing and Urban Development at 24 C.F.R. Part 100. The prohibition on disability discrimination includes the requirement that new multifamily housing with four or more dwelling units—i.e., the public and common use areas and individual apartment units (all units in buildings with elevators and ground-floor units in buildings without elevators)—be designed and constructed with certain accessible features (See 24 C.F.R. § 100.201);
- (h) Executive Order 11246, which prohibits federal contractors and federally assisted construction contractors and subcontractors, who do over \$10,000 in Government business in one year from discriminating in employment decisions on the basis of race, color, religion, sex, sexual orientation, gender identification or national origin;

- (k) Department of Homeland Security (DHS) policy to ensure the equal treatment of faith-based organizations, under which all applicants and recipients must comply with equal treatment policies and requirements contained in 6 C.F.R. Part 19;
- (l) The Applicant will comply with California's Fair Employment and Housing Act (FEHA) (California Government Code §§ 12940-12957), as applicable. FEHA prohibits harassment and discrimination in employment because of ancestry, familial status, race, color, religious creed (including religious dress and grooming practices), sex (which includes pregnancy, childbirth, breastfeeding and medical conditions related to pregnancy, childbirth or breastfeeding), gender, gender identity, gender expression, sexual orientation, marital status, national origin, ancestry, mental and physical disability, genetic information, medical condition, age, pregnancy, denial of medical and family care leave, or pregnancy disability leave, military and veteran status, and/or retaliation for protesting illegal discrimination related to one of these categories, or for reporting patient abuse in tax supported institutions;
- (m) Any other nondiscrimination provisions in the specific statute(s) under which application for federal assistance is being made; and
- (n) The requirements of any other nondiscrimination statute(s) which may apply to the application.

6. Drug-Free Workplace

As required by the Drug-Free Workplace Act of 1988 (41 U.S.C. § 701 et seq.), the Applicant certifies that it will maintain a drug-free workplace and a drug-free awareness program as outlined in the Act.

7. Environmental Standards

The Applicant will comply with state and federal environmental standards, including:

- (a) California Environmental Quality Act (CEQA) (California Public Resources Code §§ 21000- 21177), to include coordination with the city or county planning agency;

- (c) Federal Clean Water Act (CWA) (33 U.S.C. § 1251 et seq.), which establishes the basic structure for regulating discharges of pollutants into the waters of the United States and regulating quality standards for surfacewaters;

- (d) Federal Clean Air Act of 1955 (42 U.S.C. § 7401) which regulates air emissions from stationary and mobile sources;
- (e) Institution of environmental quality control measures under the National Environmental Policy Act (NEPA) of 1969 (P.L. 91-190); the Council on Environmental Quality Regulations for Implementing the Procedural Provisions of NEPA; and Executive Order 12898 which focuses on the environmental and human health effects of federal actions on minority and low-income populations with the goal of achieving environmental protection for all communities;
- (f) Evaluation of flood hazards in floodplains in accordance with Executive Order 11988;
- (g) Executive Order 11514 which sets forth national environmental standards;
- (h) Executive Order 11738 instituted to assure that each federal agency empowered to enter into contracts for the procurement of goods, materials, or services and each federal agency empowered to extend federal assistance by way of grant, loan, or contract shall undertake such procurement and assistance activities in a manner that will result in effective enforcement of the Clean Air Act and the Federal Water Pollution Control Act Executive Order 11990 which requires preservation of wetlands;
- (i) The Safe Drinking Water Act of 1974, (P.L. 93-523);
- (j) The Endangered Species Act of 1973, (P.L. 93-205);
- (k) Assurance of project consistency with the approved state management program developed under the Coastal Zone Management Act of 1972 (16 U.S.C. §§ 1451 et seq.);
- (l) Conformity of Federal Actions to State (Clear Air) Implementation Plans under Section 176(c) of the Clean Air Act of 1955, as amended (42 U.S.C. §§ 7401 et seq.);
- (m) Wild and Scenic Rivers Act of 1968 (16 U.S.C. § 1271 et seq.) related to protecting components or potential components of the national wild and scenic rivers system.

The Applicant shall not be: 1) in violation of any order or resolution promulgated by the State Air Resources Board or an air pollution district; 2) subject to a cease and desist order pursuant to § 13301 of the California Water Code for violation of waste discharge requirements or discharge prohibitions; or 3) determined to be in violation of federal law relating to air or water pollution.

8. Audits
