## **Speech to the Riverside County Board of Supervisors**

Good morning, Chair and members of the Board. My name is General Parker, and I am here as a concerned member of the Riverside County community to urge you to establish an effective, independent oversight committee for the Riverside County Sheriff's Department.

### **The Need for Oversight**

We elect Sheriffs and entrust them with the critical responsibility of enforcing the law and maintaining public safety. Yet, across California and especially here in Riverside, we have seen that the absence of meaningful oversight can lead to abuses of power, lack of transparency, and a breakdown in public trust. Often, when one takes hold of an office who is unethical or lacks integrity, the power from holding this office makes them feel the law doesn't apply to them any longer. Oversight of law enforcement is not a radical idea. It is a well-established and increasingly common tool for responsible, accountable governance, especially for such a critical and expensive public service. In fact, California's Assembly Bill 1185 (AB 1185) specifically empowers counties to create sheriff oversight boards or offices of inspector general, with the authority to issue subpoenas and conduct independent investigations

### **.Why Oversight Matters**

Public accountability is the foundation of trust between law enforcement and the communities they serve. When law enforcement is accountable, it fosters positive community support and increases safety for everyone, both the public and deputies. Checks and balances are not just a principle of good government; they are essential to ensuring that law enforcement services are fair, balanced, and just

### **.The Cost of Inaction**

The lack of effective oversight in Riverside County has led to a series of deeply troubling outcomes:

1. **Excessive Use of Force and Civil Rights Violations:** The California Department of Justice is currently conducting a civil rights investigation into the Riverside County Sheriff's Department, citing concerns about unconstitutional policing, excessive force, and conditions in our jails
2. **In-Custody Deaths:** Since 2011, nearly 250 people have died while in the custody of the Riverside County Sheriff's Department—a number that has increased by 133% even as the jail population has remained stable. In 2022, Riverside County had the third highest in-custody death rate among large California counties. These are not just numbers; they represent lives lost and families left without answers.
3. **Deputy Misconduct:** There have been multiple, well-documented cases of deputy misconduct, including arrests for sexual extortion of people in custody, illegal drug possession and trafficking, and the discriminatory restraint and handcuffing of an 11-year-old Black student with a disability. These incidents are not isolated—they point to systemic issues that demand independent scrutiny.
4. **Use of Deadly Force:** Riverside County Sheriff's deputies have been involved in more killings than 92% of other sheriff's departments in California. This is a dastardly statistic that should concern everyone.
5. **Financial Impact:** The Sheriff's Department commands a budget of approximately \$1 billion annually, making it the second largest sheriff's office in California with over 4,000 employees. Yet, taxpayers have paid nearly \$100 million, 1/10<sup>th</sup> of that budget, in lawsuit settlements related to misconduct and in-custody deaths, more than many larger counties, including Orange County. These settlements represent not only a financial burden that takes away from other necessary services, but also a moral one, while families continue to wait for answers and accountability.
6. **High Incarceration Rates:** Riverside County has the fourth highest incarceration rate among California's 58 counties, with 79% of those incarcerated being held pretrial, meaning they have not even been convicted of any crime and are wasting away in jail and losing jobs.

### **Structural Barriers to Accountability**

A major barrier to impartial investigations is the current structure in which the Sheriff's Department also controls the Coroner's Office. This merger, which is the case in most California counties, creates a clear conflict of interest when investigating deaths in custody

Despite calls from community advocates and legal experts to separate these offices, the Board has so far declined to do so as our calls have fallen on deaf ears. This only underscores the urgent need for independent oversight.

### **Also, Oversight Works—Examples from Other Counties**

Other California counties have already taken steps to address these issues. Los Angeles and Marin counties have established civilian oversight commissions that review policies, investigate complaints, and issue public reports, leading to greater transparency and improved community relations. These models show that oversight is not only possible but effective.

### **What We Need**

We are not here to single out any individual, but to address the institution as a whole. We are not here to re-litigate the past, but to ensure a safer, more just future for all Riverside County residents, we urge you to:

- Establish a civilian oversight board <sup>AND</sup> or office of inspector general with full investigatory and subpoena powers, as authorized by AB 1185
- Ensure that this body is independent, adequately resourced, and representative of the diverse communities of Riverside County.
- Separate the Coroner's Office from the Sheriff's Department to guarantee impartial investigations into deaths in custody

- Commit to transparency by making all findings and recommendations public.

### **In Conclusion**

The people of Riverside County deserve a sheriff's department that is accountable, transparent, and worthy of the public's trust. Oversight is not about undermining law enforcement. It's about strengthening it, ensuring that it serves and protects everyone equally. I urge you to act now, before more lives are lost and more trust is eroded.

**District 2 – Dylan**

Good morning. My name is Dylan Miller, and I had the honor of speaking with residents across Riverside County District 2.

During canvassing I spoke directly with community members. One of whom had lost his sister and had to deal with the coroner's department. It was " a nightmare". I can only imagine the pain of losing a loved one and then on top of that having to fight for answers and closure.

We want to lift up the courage it took for people in District 2, Supervisor Speigel, to speak up.

The people of District 2 sent a *clear and simple message*:

We want fairness.

We want safety.

We want a system that listens.

We spoke to **1,213 residents** of Riverside County District 2. **950 residents** said **yes** to oversight. Thank you.

## **District 1 – Eddie’s Speech**

Good morning. My name is Eddie, and I’m here on behalf of the people of District 1.

District 1 includes much of Riverside, Perris and Jurupa Valley. These communities are impacted by the Sheriff’s Department. It’s not just something people read about. It’s something they live.

We walked blocks and when we knocked, they answered.

This district holds grief. It holds frustration. But it also holds hope—and people who still believe their voices matter.

This district includes families who have lost loved ones in custody. And yet, those same families found the strength to support this.

For the student who asked what justice even means anymore.

For the neighbors who said, "*It's time.*"

Supervisor Medina, District 1 has done its part. We spoke to 1,412 residents. 1,127 residents said they want oversight of the Sheriff's department. The community showed up with courage and clarity.





Good morning, Chair and members of the Board. My name is Jose Santos, Vice President of the Riverside Sheriffs' Association, representing more than 4,000 deputies and law enforcement professionals who serve this county with honor and professionalism.

The Riverside Sheriffs' Association strongly opposes the proposal to create an adhoc committee to form a sheriff's oversight committee.

We know that some will deem this as necessary because of ongoing litigation against the County. However, we all know that lawsuits are not unusual in large government agencies. Lawsuits also do not automatically mean the existing oversight is broken. In fact, this proposal may **expose the County to even more legal risk**, not less.

Creating an ad hoc committee to discuss a new oversight body of activists with subpoena powers over department personnel, no safeguards for potential litigation and due process, or subject-matter expertise is not reform, it's a liability. It will invite legal challenges and lead to conflicting investigative outcomes. **This isn't theoretical. Surrounding counties have already paid the price in lawsuits, settlements, and prolonged litigation.** This kind of structure **makes the County more vulnerable** at a time when legal and financial stability should be a top priority.

We also recognize that some believe civilian input is lacking. Civilian voices matter, and that's why they're already part of the process:

- Through the Civil Grand Jury
- Through Commission on Peace Officer Standards and Training
- Through the Sheriff's Civilian Advisory Committee

Replacing that with a politically appointed body without clear qualifications is not accountability.

The consequences of this proposal are real. With the County already facing a significant budget deficit, early estimates suggest this proposal could divert **more than \$1 million a year**, just to satisfy a small group of long-standing critics. On June 8, the County told residents it couldn't afford to fully fund core sheriff department needs. So how can it now claim to have the resources to establish and operate a new oversight committee? That is not responsible leadership. That money could go toward staffing, training, or programs that actually work to improve public safety.

Vocal activist groups do not represent the entire county. They've repeatedly misrepresented the facts and are now actively trying to force the Board's hand into shaping this committee according to their demands, regardless of cost or broader public input.

We urge the Board to reject this proposal and to focus instead on supporting the systems we already have, improving where needed,

and giving our deputies the tools they need to keep communities safe.

## Address to Riverside County Board of Supervisors

OPENING: THE SHOCKING REALITY

Good morning, Supervisors.

My name is James Bahm, criminal justice researcher and reform advocate.

**Let me start with some numbers that should shock every person in this room:**

**84% of people in Riverside County jails have never been convicted of a crime.**

They are legally innocent, awaiting trial.

**Riverside County operates with only 32% of the state average for judges -**

we have 3.7 judges per 100,000 residents while the state average is 11.4, 3 times the number adjudicating cases in Riverside County

Over 500 criminal cases (including child sexual assault cases) have been dismissed in recent years due to our courts being significantly short of judges.

The current case backlog of 2,800 cases represents

\$369 million in potential detention costs at \$132,000 per year per inmate.

THE COLLABORATIVE TRUTH

These numbers are troubling to say the least.

How will this problem be solved?

For the record, YES! I fully support oversight of the Sheriff's jails.

But from a perspective of collaboration and resolution.

**Ryan Martin was at his own home when, in the middle of the night, when a raging would-be attacker seeking vengeance - while under the influence of multiple narcotics as well as alcohol**

**accompanied by three accomplices and wielding a 4-foot iron pipe - chased this young man into an enclosed courtyard.**

**There are witnesses! Sworn statements!**

**The attacker's life support, while in a medically induced coma following a botched surgery, was discontinued by an estranged relative.**

Here comes that pink elephant in the living room... WHY IS HE IN JAIL?

The circumstances of the attack meet every factor of the Castle Doctrine.

He should never have even been charged.

Yet Mr. Martin has endured 67 continuances over five+ years of pre-trial detention.

Sixty-seven!

With bail set at \$1,000,000.

You have spent nearly \$700,000 housing, feeding, and detaining this one single inmate.

He is one of hundreds, if not thousands, similarly situated.

THE DEEPER CRISIS

**Why do we have all of these people in our jail?**

**It's not because they're guilty.**

**Statistics prove that.**

The issue is far deeper.

It is a disconnect...

between front-line policing, the DA, the courts, and most importantly,

the taxpaying citizen – who has more at stake here than any other party involved.

**The \$132,000 per inmate per year**

**times 84% of our 3,500 inmates**

**is an astronomical amount of money.**

THE FINANCIAL CATASTROPHE

Let me put this in perspective:

84% of 3,500 inmates equals 2,940 people who are legally innocent.

2,940 people times \$132,000 per year equals \$388 million annually.

We are spending nearly \$400 million per year detaining innocent people.

\*\*\*\*\*

Worst of all, this is due to a complete disregard for the hard-earned dollar that this county's taxpaying citizens fork over year after year.

While actual criminals - the real attackers, the ones with iron pipes - walk free because investigators, under similar pressure, are relegated to building cases on convenience rather than evidence.

*THE CHOICE BEFORE US*

We can either continue pointing fingers at the Sheriff for managing the consequences of our collective failures,

or we can fix the system that creates those consequences.

We can continue spending \$400 million annually warehousing innocent people, or we can invest in justice that actually works.

We can continue violating the Constitution daily,

or we can restore the presumption of innocence.

The decision is before us

**Decision for collaboration.**

**Decision for comprehensive reform.**

**A decision for justice that works for everyone.**

**Justice that works for all the citizens of Riverside County.**

**They deserve their \$400 million back.**

# Systemic Reform Analysis: Riverside County Criminal Justice Pipeline

---

## EXECUTIVE SUMMARY

The current crisis in Riverside County's criminal justice system—characterized by jail overcrowding, case dismissals, and constitutional violations—stems from systemic failures at multiple points in the justice pipeline. Rather than isolated problems, these issues represent interconnected failures that require comprehensive reform addressing root causes, not just symptoms.

## THE PIPELINE PROBLEM

### Stage 1: Investigation and Charging

**Current Practice:** - Police investigate to build cases rather than solve crimes - Arrests based on circumstantial evidence to meet legal elements - Focus on "closest available suspect" rather than actual perpetrator - DA-driven policing prioritizing volume over validity

**Result:** Innocent people arrested while actual criminals remain free

### Stage 2: Prosecutorial Decision-Making

**Current Practice:** - DA's office evaluated on case volume rather than conviction validity - Circumstantial evidence assembled to support charges - Plea bargaining through "terror of illusory cases" - Limited attention to actual guilt or innocence

**Result:** Weak cases pushed forward, clogging the system

### **Stage 3: Judicial Bottleneck**

**Current Crisis:** - Riverside County: 3.7 judges per 100,000 residents - Statewide average: 11.4 judges per 100,000 residents - 68% below adequate judicial staffing - 2,800+ case backlog

**Result:** Constitutional violations, case dismissals, prolonged detention

### **Stage 4: Detention Consequences**

**Current Impact:** - Sheriff forced to house potentially innocent people indefinitely - \$132,000 per year per detainee - Jail overcrowding from upstream failures - Constitutional violations accumulating

**Result:** Sheriff blamed for managing impossible situation

## **RESEARCH FINDINGS**

---

### **Innocence Rate Analysis**

- **Estimated 50% of pretrial detainees may be factually innocent**
- Based on case-building vs. crime-solving investigation practices
- Supported by high dismissal rates when cases reach trial
- Confirmed by plea bargaining under duress rather than guilt

### **Economic Impact**

- **Current backlog cost:** \$369 million potential detention expenses
- **Individual case example:** Ryan Martin case = \$660,000+ over 5 years
- **System inefficiency:** Repeated court appearances without resolution
- **Resource waste:** Officers, attorneys, witnesses repeatedly called

- **Prosecution delays** without adequate justification
- **Court orders violated** regarding further continuances

- **Investigation quality:** Case built on circumstantial evidence
- **Prosecutorial approach:** Volume-driven rather than validity-focused
- **Judicial resources:** Insufficient judges to handle caseload
- **Detention impact:** Sheriff forced to house for 5+ years

### **Cost Analysis**

- **Direct detention:** \$660,000+ taxpayer cost
- **Court resources:** 67 hearings consuming judicial time
- **System impact:** Resources diverted from other cases
- **Constitutional violations:** Systematic denial of rights

# REFORM RECOMMENDATIONS

---

## 1. Investigation Reform

**Evidence-Based Policing:** - Investigate to solve crimes, not build cases - Require substantial evidence before arrest - Focus on actual perpetrators, not convenient suspects - Independent oversight of investigation quality

## 2. Prosecutorial Accountability

**Validity-Focused Charging:** - Evaluate prosecutors on conviction validity, not volume - Require evidence review before charging decisions - Implement case strength thresholds for prosecution - Regular review of case dismissal patterns

## 3. Judicial Resource Adequacy

**Full Staffing Implementation:** - Fund all 115 state-assessed judicial positions - Achieve statewide average of 11.4 judges per 100,000 residents - Eliminate current 68% staffing deficit - Reduce case backlog through adequate resources

## 4. Detention Reform

**Constitutional Compliance:** - Implement evidence-based bail decisions - Consider financial circumstances in bail setting - Regular review of pretrial detention length - Speedy trial enforcement mechanisms

## 5. Sheriff Support

**Recognize Downstream Impact:** - Acknowledge Sheriff manages upstream failures - Support jail oversight while addressing root causes - Provide resources for managing impossible caseload - Distinguish between policing and detention responsibilities

# IMPLEMENTATION STRATEGY

---

## Phase 1: Immediate Actions

- Fund vacant judicial positions
- Implement case review protocols
- Establish investigation quality standards
- Create prosecutorial accountability measures

## Phase 2: Systemic Changes

- Reform investigation practices
- Implement evidence-based charging standards
- Establish regular system performance reviews
- Create inter-agency coordination mechanisms

## Phase 3: Long-term Sustainability

- Monitor system performance metrics
- Adjust resource allocation based on data
- Maintain constitutional compliance standards
- Regular review and refinement of reforms
