**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. San Geronio Pass Rotary is receiving Community Improvement Designation Funds (CID) in the amount of \$2,000. Funding will support three District 5 community events, including the Skate Jam and Senior Carnival Resource Day, promoting youth engagement, senior support, and strengthened partnerships across the San Geronio Pass area.
2. Riverside Sheriffs' Association/PDF Cookies with Mrs. Claus Event is receiving Community Improvement Designation Funds (CID) in the amount of \$300 to support a family-focused holiday event for RSA members, enhancing community engagement and seasonal programming.
3. Beaumont-Cherry Valley Recreation and Park District is receiving Community Improvement Designation Funds (CID) in the amount of \$2,500. Funding will support the annual Winterfest Snow Hill, providing free, family-friendly recreation for residents in Beaumont, Cherry Valley, and surrounding Fifth District communities while strengthening local community engagement.
4. Rotary Club of Hemet is receiving Community Improvement Designation Funds (CID) in the amount of \$2,500. Funding will support the Tinsel Triathlon, an annual event that raises resources for programs addressing food insecurity, homelessness, youth development, and services for seniors and disadvantaged residents in the Fifth District.
