

**BACKGROUND:**

**Summary**

In accordance with Welfare and Institutions Code section 10485, the Riverside County Local Child Care and Development Planning Council (LPC) is a state-required planning body that assesses countywide child care and development needs, maintains a countywide child care plan, and completes required annual planning deliverables, including submission of local funding priorities (including zip code priorities) that inform state planning for subsidized child care and early learning services.

Appointments to the LPC are made jointly by the Riverside County Superintendent of Schools and the Riverside County Board of Supervisors. The Superintendent completed his appointments on December 19, 2025. This item requests approval of the Board of Supervisors' appointments listed in Attachment A for the January 2026– January 2028 term.

LPC membership is comprised of the following categories:

1. 20 percent (20%) consumers, defined as a parent or person who receives, or who has received within the past 36 months, child care services.
2. 20 percent (20%) child care providers, defined as a person who provides child care services or represents persons who provide child care services.
3. 20 percent (20%) public agency representatives, defined as a person who represents a city, county, city and county, or local education agency.
4. 20 percent (20%) community representatives, defined as a person who represents an agency or business that provides private funding for child care services, or who advocates for child care services through participation in civic or community-based organizations but is not a child care provider and does not represent an agency that contracts with the Department of Social Services to provide child care and development services.
5. 20 percent (20%) shall be appointed at the discretion of the appointing agencies.

**Impact of Residents and Businesses**

Approval of this item appoints the Board of Supervisors' members to the LPC consistent with the membership composition requirements in Welfare and Institutions Code section 10485 and reflects a good faith effort to ensure the Council's ethnic, racial, and geographic distribution is reflective of Riverside County.

In addition, it allows the Board of Supervisors to appoint LPC members to ensure alignment with the intention to increase access and quality in the Early Care and Education system in Riverside County. Finally, it enables the LPC to complete required annual planning deliverables, including submission of local funding priorities (including zip code priorities) that inform state planning for subsidized child care and early learning services in Riverside County.
