**BACKGROUND:**

Community Improvement Designation funds will be given to the following organizations:

1. **Murrieta Chamber of Commerce.** - \$1,000- The funds will be used to support the All-Chambers Mega Mixer, an event that fosters and creates economic development connections through the collaboration of partner chambers.
2. **Camp del Corazon-** \$3,000- The funds will be used to support the "DAVI Annual Golf Classic," a fundraiser to support children with congenital heart defects to go to a specialized camp with doctors and nurses.
3. **SAFE Family Justice Centers-** \$2,500- This funding will support the 2026 SAFE Futures Celebration, an event that raises funds to provide victims of domestic violence, sexual abuse, human trafficking, and child abuse with emergency hotel placement, counseling, and other essential services.
4. **The Rotary Club of Menifee California Foundation.** - \$2,500- This funding will be used to provide care packages for deployed troops and leadership training for high school students.
5. **Special Olympics Southern California Inc.** - \$2,500- This funding will be used to support the Special Olympic programs in Murrieta and Temecula with program supplies such as banners and event T-shirts.
6. **Riversie County Youth Commission - \$1,000-** This funding will be used to support the (1) Youth in Government Day an event that encourages student engagement in government and (2) to purchase marketing and program materials.
