BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Moreno Valley Chamber of Commerce is receiving Community Improvement Designation Funds (CID) in the amount of \$10,000. Funding will support Chamber sponsorships, annual events, and ongoing business advocacy and economic development programs that promote local business growth and community engagement in Moreno Valley and surrounding Fifth District communities.
2. Beaumont Chamber of Commerce is receiving Community Improvement Designation Funds (CID) in the amount of \$11,000. Funding will support Chamber sponsorships, annual events, and year-round business advocacy, networking, and community engagement activities that strengthen the local economy and community connections throughout the Fifth District.
3. Blue Zones Project is receiving Community Improvement Designation Funds (CID) in the amount of \$5,000. Funding will support community-based initiatives in the City of Banning that promote health, safety, and economic opportunity through projects such as community gardens and youth-focused placemaking improvements.
4. Youth for Truth International dba My City Youth is receiving Community Improvement Designation Funds (CID) in the amount of \$2,500. Funding will support food assistance and expanded youth programming for low-income families in the Fifth District, helping address food insecurity and provide safe, supportive opportunities for youth development.
