The Chair adheres to a strict three (3) minutes per speaker. ***Note: If you intend to give your time to a "Group/Organized Presentation", please state so clearly at the very bottom of the reverse side of this form.***

Group/Organized Presentations:

Group/organized presentations with more than one (1) speaker will be limited to nine (9) minutes at the Chair's discretion. The organizer of the presentation will automatically receive the first three (3) minutes, with the remaining six (6) minutes relinquished by other speakers, as requested by them on a completed "Request to Speak" form, and clearly indicated at the front bottom of the form.

Addressing the Board & Acknowledgement by Chair:

The Chair will determine what order the speakers will address the Board and will call on all speakers in pairs. The first speaker should immediately step to the podium and begin addressing the Board. The second speaker should take up a position in one of the chamber aisles to quickly step up to the podium after the preceding speaker. This is to afford an efficient and timely Board meeting, giving all attendees the opportunity to make their case. Speakers are prohibited from making personal attacks, and/or using coarse, crude, profane or vulgar language while speaking to the Board members, staff, the public and/or meeting participants. Such behavior, at the discretion of the Board Chair may result in removal from the Board Chambers by Sheriff Deputies.

I am requesting the opportunity to address the Board because the County's failure to follow contractually required procedures has placed veterans at immediate risk of homelessness and has left our organization without any avenue for resolution.

VetPhoenix has made repeated, documented attempts to resolve this matter administratively. We have requested guidance, corrective action, and solutions. We engaged counsel, involved County Counsel, and appeared for a scheduled meet-and-confer in good faith. County Counsel did not appear. To date, the Department has not identified any contractual deficiency, has not issued a determination, and has not followed the dispute or payment procedures required under the Agreement.

As a result of this breakdown, VetPhoenix has been forced to operate using personal and internal funds since December 1 to keep veterans housed and staff paid. Those funds are now exhausted. Without immediate intervention, operations will cease, and veterans will lose housing.

I am requesting to speak because this is no longer an administrative issue. It is a governance issue, a contract compliance issue, and a foreseeable harm issue. The Board deserves to know that good-faith performance is being met with silence, that required processes are not being followed, and that veterans are facing displacement as a direct result.

I am not asking the Board to litigate facts. I am asking for oversight, accountability, and a path to resolution before irreversible harm occurs.
