



BACKGROUND:

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports the expansion and development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that more than 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges, economic development, and workforce representatives including labor organizations. This ensures that federal funds for workforce development activities are expended on training and career coaching that meet the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official (CLEO), is responsible for appointing the WDB members for two-year terms.

Kimberly Starrs was named President and CEO of Inland SoCal United Way & 211 in April 2023 after serving in various positions over the course of her 18-year tenure in the network. In partnership with the team at ISCUW, she was instrumental in the expansion of the agency from \$2.7M in annual revenue to more than \$300M raised over 3 years. Born and raised in the Coachella Valley, she is proud of her mixed Latinx/Euro heritage and lives with her partner and

two children in Beaumont. She holds a Master of Business Administration and is a Certified Fundraising Executive. She previously served as a board member for the Beaumont Chamber, an Economic Development Committee member for the City of Beaumont, the Chair for the Association of Fundraising Professionals Inland Empire Chapter, Chair of the Riverside County Non-Profit Roundtable, and member of the Riverside Community College District School of Business Advisory Committee. The driving principle of her life is the belief that all life has equal value and that we can all build a community where our loved ones can thrive.

Kimberly Starrs has expressed interest in serving on the Riverside County Workforce Development Board as the Community Based Organization representative for All Districts. If appointed, she will serve a two-year term commencing March 5, 2026, through March 5, 2028.
