RECOMMENDED MOTION: That the Board of Supervisors:


1. Set the public hearing to receive public comments on the Annual Adjustment to the Waste Collection Rates within the County Franchise Area 10;

BACKGROUND:

Summary

Waste Collection Franchise Agreements covering unincorporated areas of Riverside County were phased in between 1997 and 1998. Within each of the existing eleven Franchise Agreements is a provision for an annual adjustment of the rates effective each July 1st. Franchise area 10 is generally the unincorporated county area within the upper Coachella Valley as shown in Attachment C.

This adjustment to the rates includes consideration of a number of indexes, detail below in Section 10.4.1 of the current Franchise Agreement:

1. The Consumer Price Index (Bureau of Labor Statistics – CPI-U Series CUURS49CSA0)
2. The Disposal Tipping Fee
3. The Recycling Processing Fee
4. The Organics Processing fee

The detailed rate calculation worksheets factoring in the CPI increase have been reviewed for accuracy by the Department of Environmental Health and a third-party waste consultant. The updated rate sheets are maintained by the Department of Environmental Health.

Impact on Residents and Businesses

Presently, a residential customer pays \$37.78 per month for three bin curbside service. The proposed rate change would increase by \$1.28 to \$39.06 per month.

Business rates will also increase by varying amounts, depending on the size of the bins and the frequency of service provided.

The complete rate sheets are provided as Attachment B.

The approval of this change will result in no cost to the County; implementation expenses are borne by the franchisee.

3 **A RESOLUTION OF THE COUNTY OF RIVERSIDE ADOPTING SOLID WASTE COLLECTION**

4 **RATES IN THE UNINCORPORATED AREAS FOR FY 2026-2027**

6 WHEREAS, California Government Code section 25827 authorizes the Board of Supervisors to
7 prescribe terms and conditions by Resolution for the collection of solid waste in the unincorporated areas of
8 Riverside County; and

9 WHEREAS, California Public Resources Code section 40059 authorizes the County of Riverside to
10 determine all aspects of solid waste handling which are of local concern, including, but not limited to, whether
11 the services are to be provided by wholly exclusive franchise, contract, permit, or otherwise, and the charges and
12 fees for such service; and

13 WHEREAS, Riverside County Ordinance No. 745 (as amended through 745.4) established that a Solid
14 Waste Hauler, duly franchised by the County of Riverside, ("Franchisee") shall be entitled to payment for
15 services rendered in the amounts as specified in a Resolution adopted by the Board of Supervisors; and

16 WHEREAS, on September 10, 2024, following a duly noticed public hearing, the Board of Supervisors
17 approved the First Amended and Restated Franchise Agreements ("Franchise Agreements") with its four
18 exclusive Franchisees, Waste Management Collection and Recycling, Inc., CR&R Incorporated, Desert Valley
19 Disposal, Inc., and Burrtec Waste & Recycling Services, LLC, to include provisions for new service and
20 compliance programs to meet the organic waste reduction goals mandated by the State pursuant to Senate Bill
21 No. 1383 for solid waste collection services in the unincorporated areas of the County; and

22 WHEREAS, the Franchise Agreements provide provisions for an annual rate adjustment process for a
23 period, including any applicable adjustments for inflation based on changes in the Consumer Price Index
24 ("CPI"), with no less than thirty (30) days' notice provided, pursuant to Government Code sections 53755 and
25 53756; and

26 WHEREAS, on or before March 15, 2026, the Franchisees submitted rate applications to the County
27 pursuant to the terms of the Franchise Agreements which contained the annual rate adjustment calculations, an

1 updated rate schedule, and any other information necessary to support the proposed rate adjustments to the Solid
2 Waste Collection Rates to be charged during Fiscal Year 2026-2027; and

3 WHEREAS, the Department of Environmental Health has reviewed the proposed rate adjustment
4 submitted by each Franchisee and recommends the Board of Supervisors approve the proposed Solid Waste
5 Collection Rates for Fiscal Year 2026-2027 as adjusted for inflation, effective on July 1, 2026; and

6 WHEREAS, the Board of Supervisors acknowledges the need for the CPI increase of the Solid Waste
7 Collection Rates to address cost increases in providing the mandated additional services and oversight in
8 compliance with SB 1383.

9 NOW, THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED that the Board of
10 Supervisors of the County of Riverside, State of California (the "Board"), in regular session assembled on May
11 12, 2026, at 9:30 a.m. or soon thereafter, in the meeting room of the Board of Supervisors located on the 1st
12 floor of the County Administrative Center, 4080 Lemon Street, Riverside, California, based upon review of the
13 evidence and information presented on the matter, and upon closing of the public hearing, hereby finds and
14 declares as follows:

- 15 1. That the foregoing Recitals are true and correct and are incorporated herein by this reference.
- 16 2. The Solid Waste Collection Rates for Fiscal Year 2026-2027 shall be adjusted for inflation based
17 on the CPI of 3.2% to the service component of the Franchisee's fees in the unincorporated areas of
18 Riverside County.
- 19 3. Franchisees shall provide notice of any adjustment to rates in their respective service areas:
 - 20 a. Waste Management Collection and Recycling, Inc. in Franchise Areas 1, 3, and 4
 - 21 b. CR&R Incorporated in Franchise Areas 5, 6, 7, 9, and 13
 - 22 c. Desert Valley Disposal, Inc. in Franchise Area 10
 - 23 d. Burrtec Waste & Recycling Services, LLC in Franchise Area 12.
- 24 4. The Board adopts the Solid Waste Collection Rates for Fiscal Year 2026-2027 to take effect on July
25 1, 2026. The previous rates shall be superseded upon the effective date of the newly adopted rates.
- 26 5. This Resolution shall take effect immediately upon its adoption.

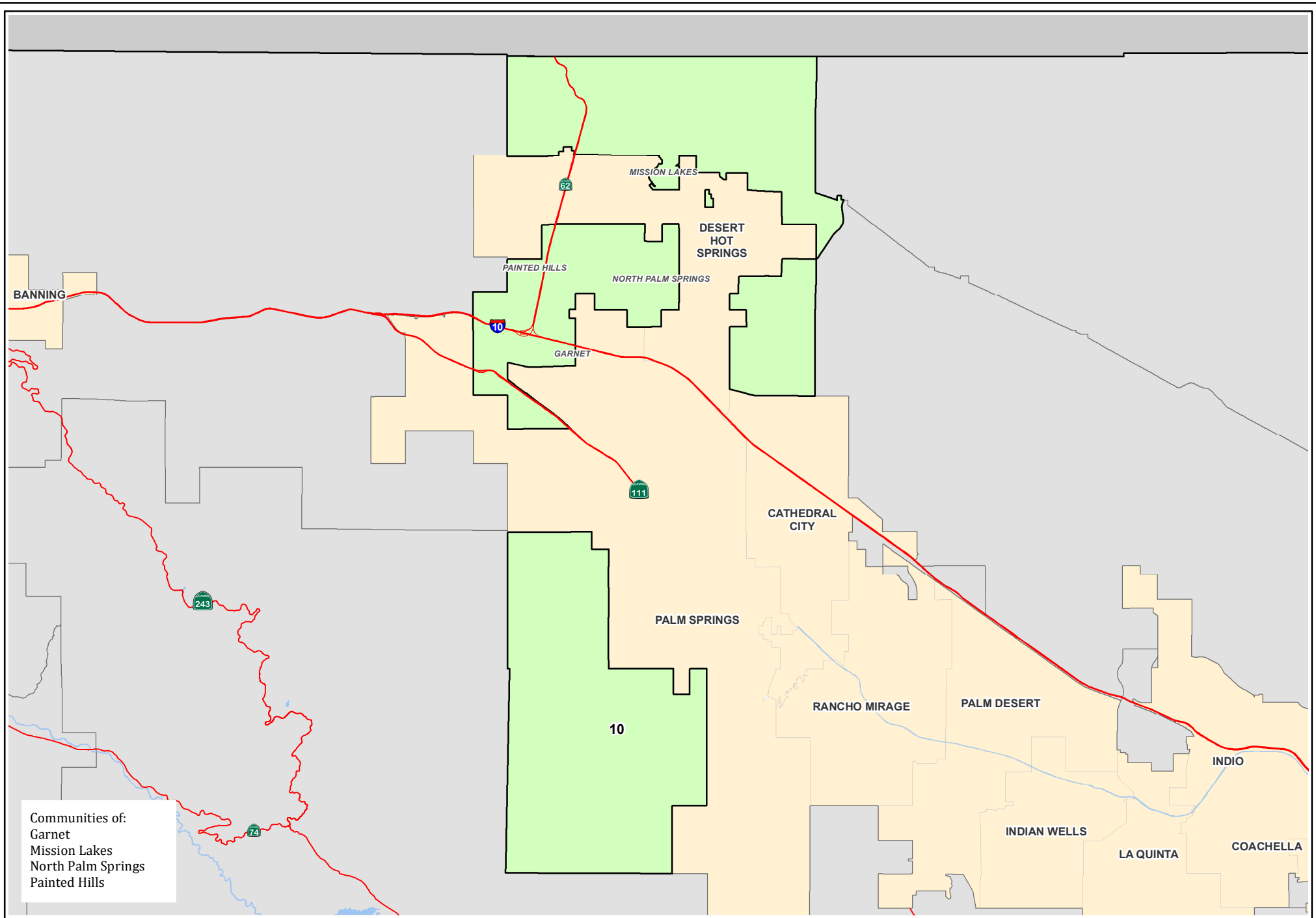

**RESOLUTION NO. 2026-030
A RESOLUTION OF THE COUNTY OF RIVERSIDE, ADOPTING SOLID WASTE COLLECTION RATES IN THE UNINCORPORATED AREAS FOR FY 2026-2027**

WHEREAS, California Government Code section 25827 authorizes the Board of Supervisors to prescribe terms and conditions by Resolution for the collection of solid waste in the unincorporated areas of Riverside County; and

WHEREAS, California Public Resources Code section 40059 authorizes the County of Riverside to determine all aspects of solid waste handling which are of local concern, including, but not limited to, whether the services are to be provided by wholly exclusive franchise, contract, permit, or otherwise, and the charges and fees for such service; and

WHEREAS, Riverside County Ordinance No. 745 (as amended through 745.4) established that a Solid Waste Hauler, duly franchised by the County of Riverside, ("Franchisee") shall be entitled to payment for services rendered in the amounts as specified in a Resolution adopted by the Board of Supervisors; and

WHEREAS, on September 10, 2024, following a duly noticed public hearing, the Board of Supervisors approved the First Amended and Restated Franchise Agreements ("Franchise Agreements") with its four exclusive Franchisees, Waste Management Collection and Recycling, Inc., CR&R Incorporated, Desert Valley Disposal, Inc., and Burrtec Waste & Recycling Services, LLC, to include provisions for new service and compliance programs to meet the organic waste reduction goals mandated by the State pursuant to Senate Bill No. 1383 for solid waste collection services in the unincorporated areas of the County; and

WHEREAS, the Franchise Agreements provide provisions for an annual rate adjustment process for a period, including any applicable adjustments for inflation based on changes in the Consumer Price Index ("CPI"), with no less than thirty (30) days' notice provided, pursuant to Government Code sections 53755 and 53756; and

WHEREAS, on or before March 15, 2026, the Franchisees submitted rate applications to the County pursuant to the terms of the Franchise Agreements which contained the annual rate adjustment calculations, an updated rate schedule, and any other information necessary to support the proposed rate adjustments to the Solid

WHEREAS, the Department of Environmental Health has reviewed the proposed rate adjustment submitted by each Franchisee and recommends the Board of Supervisors approve the proposed Solid Waste Collection Rates for Fiscal Year 2026-2027 as adjusted for inflation, effective on July 1, 2026; and

WHEREAS, the Board of Supervisors acknowledges the need for the CPI increase of the Solid Waste Collection Rates to address cost increases in providing the mandated additional services and oversight in compliance with SB 1383.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED that the Board of Supervisors of the County of Riverside, State of California (the "Board"), in regular session assembled on May 12, 2026, at 9:30 a.m. or soon thereafter, in the meeting room of the Board of Supervisors located on the 1st floor of the County Administrative Center, 4080 Lemon Street, Riverside, California, based upon review of the evidence and information presented on the matter, and upon closing of the public hearing, hereby finds and declares as follows:

1. That the foregoing Recitals are true and correct and are incorporated herein by this reference.
2. The Solid Waste Collection Rates for Fiscal Year 2026-2027 shall be adjusted for inflation based on

the CPI of 3.2% to the service component of the Franchisee's fees in the unincorporated areas of Riverside County.

3. Franchisees shall provide notice of any adjustment to rates in their respective service areas:

a. Waste Management Collection and Recycling, Inc. in Franchise Areas 1, 3, and 4

b. CR&R Incorporated in Franchise Areas 5, 6, 7, 9, and 13

c. Desert Valley Disposal, Inc. in Franchise Area 10

d. Burrtec Waste & Recycling Services, LLC in Franchise Area 12.

4. The Board adopts the Solid Waste Collection Rates for Fiscal Year 2026-2027 to take effect on July 1, 2026. The previous rates shall be superseded upon the effective date of the newly adopted rates.

5. This Resolution shall take effect immediately upon its adoption.
